Tytherington FC Terms and Conditions

TFC Club T&CS V1.1

When signing up with Tytherington FC, there are several terms, conditions, and expectations that both you and your child must agree to and abide by.

Registration and Payment

Registration is done through Teamfeepay and must be completed for each season that you or your child play for a team within the club. Details regarding registration and payment are provided by your respective manager and can also be obtained by contacting a club official.

By 'ticking' the boxes during the registration process, you confirm that you agree to the conditions outlined below. Any breach of these conditions will have consequences. You will not be able to register without consenting to these terms.

Signing On Consent - IMPORTANT

I consent to the following terms and conditions. I agree to my son/daughter becoming a member of Tytherington Football Club and accept that both they and I must abide by the current rules of Tytherington FC, The Cheshire County FA, The FA, and any league in which they may play. I also accept that, while participating, my child will be under the care of the team manager, assistants, or other adults authorized by the club. I have read, understood, and agree to comply with the Club Rules (available on the website).

Parental Responsibility - IMPORTANT

I consent to staying with my child while they are playing a match or training and not leaving them with the manager or coach unless previously arranged with the manager. If I need to be absent for a specific reason, I will speak with the manager beforehand to arrange an appropriate solution.

Payment Consent - IMPORTANT

I agree to pay the relevant (non refundable) signing up fee and membership fees to the club in accordance with the rate for the season. I understand that failure to make payment by the prescribed date will result in my child being suspended from playing until payment is made. I also understand that any outstanding monies owed by the end of the season may result in debt recovery procedures being initiated.

Kit - IMPORTANT

I consent to returning any club home shirts to the team manager, within 14 days, when my child leaves the club. Failure to return this kit may delay my child's removal from the club and could result in the involvement of a debt recovery company to recover the cost. If I have purchased clothing through the club shop, this is my property and does not need to be returned.

Respect Consent - IMPORTANT

I have read, understood, and agree to the FA Respect policy, which can be found here: FA Respect Policy.

Media Consent - IMPORTANT

I consent to photographs/films of my child being taken for use on the Tytherington FC website, social media groups, newspaper articles, etc., in accordance with the FA Photography Guidelines, unless the club is notified during registration that the child is under a Protection Order

Coverage Consent - IMPORTANT

While every effort is made to ensure that playing for Tytherington FC is an enjoyable and safe experience, players take part at their own risk, just as they would in any school or sports activity. Tytherington FC has public liability insurance, and additional medical coverage up to £7,500 per player, per incident, is provided through your membership whilst playing in team kit.

First Aid Consent - IMPORTANT

I consent to providing medical details and any relevant information that may need to be known by the Tytherington Coaching Staff, including allergies, medication needs, or other health concerns. I also confirm that I will provide a spare inhaler (if applicable) or any necessary medication to the coaching staff, and I give permission for Tytherington FC staff to provide medical assistance during training and matches.

Fines - IMPORTANT

I acknowledge and accept that I am personally responsible for any fines incurred because of my conduct in matches (e.g., yellow/red cards or other disciplinary actions). I agree to pay any such fines within 14 days of the charge being posted to my Team Fee Pay account. Failure to do so may result in disciplinary action, including suspension from the club.

I also understand that I may be held liable for any fines issued directly to the club because of misconduct for which I am found to be at fault. Failure to pay such fines within the stated period may likewise result in disciplinary measures, including suspension.

A late payment fee of £3 will be added for every additional 14-day period that a fine remains unpaid beyond the original deadline.

It is my responsibility to check my Team Fee Pay account regularly. Repeated failure to settle fines may lead to further consequences, including suspension from training and matches until full payment is made.

I understand that the club reserves the right to recover any associated costs incurred as a result of my misconduct.
